GOVE COUNTY SCHOLARSHIP FUND

The Faith Technologies Incorporated (FTI) - Gove County Scholarship Fund was established to support the success of the local community in which FTI's Smoky Hill Ranch is located. Three scholarships will be awarded to graduating high school students who plan to attend an accredited technical college or a two- or four-year university or college. All recipients must be enrolled on a full-time basis. The primary scholarship award amount is \$1,000, the secondary is \$500 and the tertiary is \$500.

Scholarship candidates are evaluated by FTI based on the following criteria:

- Leadership qualities and potential.
- Involvement in extracurricular activities, volunteerism and/or employment.
- Involvement with ranching, farming, or wildlife.
- A cumulative GPA (grade point average) of 2.8 or above on a 4.0 scale or comparable.
- The candidate's own typewritten statement, prepared in response to the following:
 - *Describe how you have given back to your community and how you and others can give back after your college career.*

Submit the completed application and attachments to:

- High School Student Counselor.
- Documents will be submitted electronically to Beth Packard by the Counselor.

Applications must be submitted to FTI by 4:00 p.m. on Tuesday, April 16, 2024. The application packet must include:

- Completed Application
- Typewritten Statement (approximately 500 words).
- Grade Transcripts *and* ACT or SAT scores
- Completed Activity/Employment Form

The scholarship selection committee is comprised of individuals familiar with Gove County, Western Kansas and FTI. All decisions made by the Scholarship Selection Committee are final.

The recipients will receive a recognition certificate, and upon verification of registration at an accredited technical college or a two- or four-year college or university, the scholarship check will be sent directly to the school in which they are enrolled.
