Transportation Report:

Mrs. Zeigler reported on a used bus for sale in Plainville that Arlan Wolf has looked at. Used bus has 124,000 miles and would cost \$2,750. Bus 3 has 255,000 miles. Purchasing the used bus could put off a bus purchase until after the Block Grant is over.

Grade School Building Report:

Mr. Rummel will present awards and Mrs. Zeigler will honor AR Accomplishments. Mr. Kuchera will direct a play day on the 18th. Post tests data help to show students' growth. Continuous Improvement sheets will be sent to parents with report cards which will have three positives about each student and one goal that the parents can help with for the summer. Hospital Daycare will be using cafeteria, restrooms, and playground for school age daycare. Mrs. Zeigler hopes to use some of the desks in reading room upstairs for new 4th grade room.

Junior-Senior School Building Report:

Technology committee discussed updating e-mails to quintershools.org this summer, linking AR books, and one to one Chrome books. Network of Complimentary Schools would like to use a school vehicle for annual conference. Quinter students did well on the Work Keys test. Mr. Countryman reviewed overall results. A new Graduation policy was presented to the Board for review and will be brought back when the handbooks will need to be approved. Nineteen students graduated Saturday. Looking ahead to final exams, teacher in-service and summer projects.

All-School Report:

Teachers consistently hear compliments about our students at both schools as they go out on field trips. Winding up State Assessments with students who were absent during testing periods.

Superintendent's Report:

Mrs. Zeigler reviewed facts about SB 7 and school district block grants. No school will get more money. KPERS State aid is the only flow through dollars that will be going up. Lawsuit is still pending. Budget at a glance was reviewed. Mrs. Zeigler reviewed research she had charted on teacher salary-benefit packages, and textbook fees from other similar districts compared to the Class 1A average.

Superintendent's Report Cont.:

Health insurance for a single will be offered to Special Education Para-Professionals if they stay as Quinter staff or are moved to NKESC. Mrs. Zeigler asked the Board members for their thoughts and would like to visit with the Paras before the Board makes the final decision at the May meeting. Mr. Countryman reviewed the Mentoring Program Handbook that was emailed out before the meeting that is now required and will need board approval. Quinter has had a mentoring program, but one change would be to have new teachers go into mentor's classroom and a mentor would go into observe and direct the new teacher in his/her own classroom.

Old Business:

Health insurance update: Mr. Shriver from KASB stated that in addition to the six smaller schools, two larger districts are interested which would make more than 1000 lives to make the plan viable. Still waiting on more exact numbers. Staff will need to fill out profiles at beginning of next school year to know rates for sure. Discussion was held on survey results and city recreation director letter concerning 6th grade students participating in sports. Two decisions will need to be made; 1. Approval of 6th grade participation, and 2. JH sports kept during school or moved to after school. Decision was tabled until the May meeting so Mr. Countryman could put together a schedule of gym use if moved to after school.

Dear Board members and Administration,

While I understand the necessity of the Board's decision to eliminate my position as certified Library Media Specialist and Seventh Grade English Instructor, it is with considerable regret that I write this official letter of resignation. I appreciate the administration's efforts to keep me on as a member of our certified staff with their offer of two different positions. Unfortunately, I do not feel that the acceptance of either offer is in the best interests of the students, or myself.

I have neither the degree nor the experience in English to best serve the needs of our high school students. Writing is such an important skill for students to have, and I do not have the background or expertise that is needed to adequately teach that at the high school level. The expectations that would be placed on me as a twenty-four year teacher with a master's degree would be unrealistic for me to fulfill given the fact that my undergraduate degree is in Communications and my master's degree is in Library Science.

I also feel that I am not qualified for the second position that was offered, teaching computers part time in the grade school. I have never taken any computer classes, nor am I at all familiar with Mac computers. In addition, my financial circumstances are such that I cannot afford to take a position as a part-time certified staff member.

Because my circumstances allow for it, I did offer to take a position as a full time library aide, with the hope that my offer would allow both libraries to remain open all day every day. I respectfully request that you will earnestly consider my offer.
