AD Report:

John Crist congratulated the Quinter girls' basketball team/coaches for qualifying for state and the boys' for how well they played at sub-state. He also complimented the fans for their turnout and behavior at the sub-state – sharing that he heard positive comments from several out of town spectators. Grade School Building Report:

Mrs. Kephart is working on second round of teacher evaluations for first and second year teachers. Kindness Club had its first meeting - members left kind messages on the sidewalks at the GS with pennies face up inside hearts for the students to find in the morning. At GS faculty meetings the teachers have been reviewing reading instruction for: strengths, areas for improvement, norms, and needs. At the next GS faculty meeting teachers will work on setting two building goals for KESA; after that, they will look at math instruction for: strengths, areas for improvement, norms, and needs.

Junior-Senior School Building Report:

Mrs. Kephart reported that Brady Albin tied for 9th place at the regional Sunflower Spelling Bee and was the top finisher for Gove County. Senior class trip policy was reviewed. Mr. and Mrs. Countryman are currently attending the Kansas Can Symposium in Manhattan, Kansas. A large part of the conference focuses on Problem Based Learning and implementation of Individual Plans of Study.

All-School Building Report:

Mrs. Kephart reviewed projected enrollment numbers for 2018-2019. Mrs. Kephart is starting to plan for next year. Enrollment numbers in kindergarten are looking like only one class will be needed. Mrs. Kephart with Mr. Countryman are also looking at band/vocal and may recommend offering more classes or adding staff. It's possible USD 293 might need to add a position at the high school and/or grade school.
